- 2. There will be full airing of the issues at a preliminary injunction hearing starting at 9 a.m. on Monday, October 27, 2014. The status quo shall be maintained pending the outcome of the hearing on October 27.

- 3. In the interim, neither the parties nor anyone under their direct control shall post on the Internet any comments specifically and directly related to the factual allegations that form the basis of Ellora Cave's defamation complaint; further, they shall not comment online, directly or indirectly, on the allegations that form the basis of the defamation complaint. Nothing herein shall prohibit Plaintiffs from responding to defamatory posts or re-posts made by third parties related to the issues raised in this litigation.
- 4. Except as provided for herein, neither party is prevented from or restricted in blogging or otherwise commenting on the Internet or otherwise about any other matter. Defendants may solicit witnesses online and otherwise who may aid in their defense of the underlying allegations.
