This matter is before the Court upon several pending motions. Upon due consideration of the issues raised in each, the Court makes the following rulings and orders:

- (1) The Court finds no emergent necessity for a hearing or to act “*sua sponte*” on the issues raised in Defendants’ (KNR and Ghoubril) Joint Motion for *Sua Sponte* Order Prohibiting Defamatory Statements or Dissemination of Misleading Information to the Public, Media or Press; Request for Emergency Hearing and Sanctions against Plaintiffs’ counsel. The Court will issue a detailed ruling on this Motion within the coming days. The present request for an Emergency Hearing is **OVERRULED**.
 - (2) For good cause shown, Plaintiffs are granted leave to file under seal Defendant Nestico’s deposition transcript and portions of Plaintiffs’ Motion to Compel Defendant Nestico’s Continued Deposition. The materials shall be filed under seal for review by this Court under the Protective Order issued on September 12, 2017.
