Just this month alone there were 13 mistakes made by your regarding the referred to's. This cannot happen. I work hard to maintain a close relationship with chiropractors and I am in contact with most of them several times a day.

Furthermore, every single intake that gets done by attorneys, an email should be sent indicating what the referral is, where the case is referred to and how/when/who is signing case.
