 COUNTY OF Franklin) ss: AFFIDAVIT OF THOMAS P. FISHER

NOW COMES AFFIANT, Thomas P. Fisher, having first been sworn upon his oath, and states for his Affidavit as follows:

1. I am over 18 years of age, of sound mind, and otherwise competent to testify.
2. I am retired from the Columbus Police Department, having served a total of thirty years there. The first seven years I was a Police Officer, and the remaining twenty-three years I was a Detective. While working as a Detective I served in various divisions of the Columbus Police Department including Special Investigations, Homicide, Fraud, and Sexual Crimes. I retired from the Columbus Police Department in 2000.
3. Following my retirement from the Columbus Police Department, I worked for approximately eight years as a Private Investigator for Colley Investigations in Columbus, Ohio. I then worked as a Background Investigator for a government contractor, where I performed background investigations for a number of federal agencies including the National Security Agency (NSA) and Customs and Border Protection (CBP).
4. Since approximately 2013, I have performed investigative services for the law firm Kisling, Nestico and Redick ("KNR") as an independent contractor, and I am paid a flat rate for all services requested by KNR on a given case assigned to me.
5. When I am assigned a case to investigate on behalf of KNR, in addition to meeting with a new client to obtain a signature on the KNR contingency fee agreement, I also obtain signatures on patient authorizations or Medicare "Proof of Representation" forms where appropriate, review the Ohio Traffic Crash report and interview the client about the collision, identify the responsible party and any potential witnesses to the crash, obtain copies of any medical insurance information or medical records in the possession of the client, take vehicle photos and photos of any visible physical injuries, and collect and document any further information to pass along to the assigned attorney at KNR.
6. From time to time after the original investigation is complete I perform additional work on a case. Some examples of additional tasks I have performed include picking up and delivering medical records, meeting with clients to obtain additional information or

photographs, securing supplemental police investigation reports, photographing the accident scene and crosswalk signs, and locating clients.

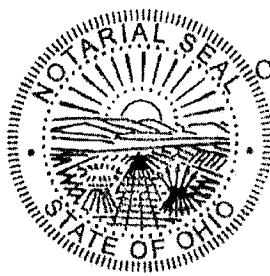
