- (1) Plaintiffs' May 1, 2019 Motion to Compel Ghoubril Settlement Agreement and Divorce Decree (and see Defendant Ghoubril's May 7, 2019 brief in opposition with non-party Julie's separate response; Plaintiffs' May 24, 2019 Reply in Support)

Plaintiffs Motion to Compel the Ghoubril Settlement Agreement and Divorce Decree **OVERRULED**. Plaintiffs may obtain a copy of the document from the Clerk of Court for the Domestic Relations Court, as it is a case document filed on the Domestic Relations Court's docket.

- (2) Plaintiffs' May 24, 2019 Motion for Protective Order to enforce class-discovery deadline (KNR Defendants' May 31, 2019 Brief in Opposition; Plaintiffs' June 11, 2019 Reply in Support)

The Court considers this matter MOOT because the set a deadline for class-certification discovery on April 15, 2019 has expired and all Defendants have since responded in opposition to Plaintiffs' Motion for Class-Action Certification and Appointment of Counsel under Civ.R. 23. The parties shall hold further discovery in this case in abeyance until the Court rules on the class-certification issue.
