- Plaintiffs' Sixth Amended Complaint rests on baseless factual and legal **12.** allegations known by Plaintiffs to be false and/or misleading. Plaintiffs' institution and prosecution of this case under these circumstances constitutes frivolous conduct, in violation of Ohio Revised Code§ 2323.51.
- 13. Floros did not act in any manner or state of mind which justifies the imposition of punitive damages. Imposing punitive damages against Floros under the circumstances at issue here would violate the Constitution, statutes, and law of Ohio, and the Eighth Amendment excessive fines clause, the due process provisions and the equal protection provisions of the United States Constitution.

- 14. Any alleged injury or damage claimed by Plaintiffs, or some or all of the purported classes, which Defendant denies, was caused in whole or in part by the intervening and/or superseding acts, events, or omissions of persons or entities.
- 15. Plaintiffs and some or all of the purported classes have failed to mitigate any damages caused by any purported injury.
 - **16.** Plaintiffs' Complaint fails for insufficiency of process and service of process.
- 17. Plaintiffs' claims are barred, in whole or in part, by the doctrine of accord and satisfaction and novation.
- 18. Plaintiffs' fraud claims are not pled with particularity as required by Ohio R. Civ.P. 9(b).
- 19. To the extent Plaintiffs have suffered any legally cognizable damages (which is denied), Floros is entitled to a set off for the amount his fees were discounted as a courtesy to any Plaintiff.
- 20. Plaintiffs' claims, and some or all of the purported classes, in whole or in part, are barred by operation of the applicable statutes of limitation or other limitation periods.
- 21. Floros incorporates the affirmative defenses pleaded in all prior Answers filed in this case as if fully rewritten herein.
- 22. Floros incorporates the Answers of the other Defendants, including but not limited to their prior Answers.
- 23. Floros incorporates all Motions for Judgment on the Pleadings, Motions to Dismiss, Counterclaims, and related briefs and motions filed in this case as if fully rewritten herein.
 - 24. Floros reserves the right to amend its Answer to assert any additional defenses,

cross-claims, counterclaims and/or third-party complaints to the extent that discovery in this matter reveals any basis for the assertion of such defenses.

WHEREFORE, having fully responded to Plaintiffs' Complaint herein, Floros requests that the Complaint be dismissed with prejudice, that it recover its costs, expenses, and reasonable attorney's fees incurred herein, and for such other and further relief as the Court deems just and equitable.
