Plaintiffs hereby request, pursuant to Civ.R. 6(B), a 7-day extension time in which to file their supplemental brief in support of class certification of Class A (the “price gouging” class). Following appeal of this Court’s prior class certification order to the Ninth District, the case was remanded for this Court to undertake a more rigorous analysis as to whether certification of Class A satisfies the predominance and superiority requirements of Civ.R. 23. The Court held a status conference on November 9, 2022, and allowed supplemental briefing on the remanded issues. Plaintiffs were given 14 days (to November 23, 2022) to file an initial brief.

Plaintiffs’ counsel needs additional time to prepare their brief due to need to accommodate for Plaintiffs’ counsel’s workload, and the upcoming holiday. Following the status conference, several pressing matters arose which required Plaintiffs’ counsel’s attention, including a jury trial.

This motion is not made for purposes of delay, and Plaintiffs’ requested extension of just one week will not cause to prejudice any party.

WHEREFORE, Plaintiffs hereby request a 7-day extension of time (to November 30, 2022) in which to file their supplemental brief in support of Rule 23 certification of Class A (the “price gouging” class) to address the predominance and superiority issues raised by the Ninth District upon remand.
