Plaintiffs hereby request, pursuant to Civ.R. 6(B), an additional 14-day extension of time in which to file a supplemental brief that addresses whether certification of Class A (the “Price-Gouging Class”) satisfies the “predominance and superiority” requirements of Civ.R 23(B) in this case, following remand of this matter from the Ninth District Court of Appeals.

Plaintiffs’ counsel originally requested only 14 days to file an initial brief, but that proved to be insufficient due, in part, to an unexpected increase in counsel’s workload. Plaintiffs then requested and were granted an additional 7 days (which included only 3 business days due to the Thanksgiving holiday). Despite their diligent efforts, Plaintiffs’ attorneys require additional time to complete the necessary “rigorous analysis” called for by the Ninth District’s ruling while also keeping up with their pre-existing obligations in other pending matters, and are requesting one final 14-day extension (to December 14, 2022) to complete and file the brief. This motion is not made for purposes of delay, and given that this matter was only recently remanded after being on appeal for nearly years, Plaintiffs’ requested extension will not unduly delay these proceedings or prejudice any party.
