The Court held a status conference on November 9, 2022, and allowed supplemental briefing on the remanded class action alleged by Plaintiff involving Dr. Ghoumbrial and the KNR Defendants. Plaintiffs were given 14 days (to November 23, 2022) to file an initial brief. On November 22, 2022, Plaintiff moved for an additional 7 days (until November 30, 2022), to the file the brief. Plaintiff now moves the Court for an additional 14 days (until December 14, 2022) bringing the total time for preparing Plaintiffs' brief to 35 days.

The KNR Defendants have no objection to the requested extension so long as defendants are provided an equal and reciprocal amount of time to respond. Allowing Plaintiff another 14 days pushes the Defendants' response date to December 28, 2022, which would require preparation time over the Christmas holiday. Defendants request that the response date be the same 35 days Plaintiffs have requested to submit their brief, or until January 18, 2023.
