COUNT ONE

DO FIND AND PRESENT, that **TERREIONNA SHAVONN PASCHAL** on or about the 19th day of April, 2023, in the County of Summit and State of Ohio aforesaid, did commit the crime of **AGGRAVATED MURDER** in that she did purposely cause the death of, [REDACTED] while committing, or attempting to commit, or while fleeing immediately after committing or attempting to commit the offense of Aggravated Robbery, O.R.C. 2911.01 (A)/(C) in violation of Section 2903.01 (B), 2929.02(A) of the Ohio Revised Code, an UNCLASSIFIED FELONY, contrary to the form of the statute in such case made and provided and against the peace and dignity of the State of Ohio.

SPECIFICATION ONE TO COUNT ONE O.R.C. 2941.145(A) FIREARM SPECIFICATION - 3 YEAR

The Grand Jurors further find and specify that Terreionna Shavonn Paschal had a firearm on or about her person or under her control while committing the offense and displayed the firearm, brandished the firearm, indicated that she possessed the firearm, or used it to facilitate the offense, in violation of Section 2941.145(A) of the Ohio Revised Code, contrary to the form of the statute in such case made and provided and against the peace and dignity of the State of Ohio.

SPECIFICATION ONE TO COUNT THREE O.R.C. 2941.145(A)
FIREARM SPECIFICATION - 3 YEAR

And the Grand Jurors of the State of Ohio, within and for the body of the County of Summit aforesaid, on their oaths in the name and by the authority of the State of Ohio, DO FURTHER FIND AND PRESENT, that **TERREIONNA SHAVONN PASCHAL** on or about the 19th day of April, 2023, in the County of Summit and State of Ohio aforesaid, did commit the crime of **AGGRAVATED ROBBERY** in that she did, in attempting or committing a theft offense, as defined in section 2913.01 of the Revised Code, or in fleeing immediately after the attempt or offense upon [REDACTED] did have a deadly weapon, to wit: a firearm, on or about her person or under her control and either displayed the weapon, brandished it, indicated that she possessed it, or used it and/or inflicted, or attempted to inflict, serious physical harm on Todd Morgan, in violation of Section 2911.01(A), 2911.01(C) of the Ohio Revised Code, a **FELONY OF THE FIRST DEGREE**, contrary to the form of the statute in such case made and provided and against the peace and dignity of the State of Ohio.

SPECIFICATION ONE TO COUNT FIVE O.R.C. 2941.145(A)
FIREARM SPECIFICATION - 3 YEAR

And the Grand Jurors of the State of Ohio, within and for the body of the County of Summit aforesaid, on their oaths in the name and by the authority of the State of Ohio, DO FURTHER FIND AND PRESENT, that **TERREIONNA SHAVONN PASCHAL** on or about the 19th day of April, 2023, in the County of Summit and State of Ohio aforesaid, did commit the crime of **TAMPERING WITH EVIDENCE** in that she knowing that an official proceeding or investigation was in progress, or was about to be or likely to be instituted, did alter, destroy, conceal, or remove any record, document, or thing, with purpose to impair its value or availability as evidence in such proceeding or investigation and/or make, present, or use any record, document, or thing, knowing it to be false and with purpose to mislead a public official who is or may be engaged in such proceeding or investigation, or with purpose to corrupt the outcome of any such proceeding or investigation, in violation of Section 2921.12(A), (1), (2), 2921.12(B) of the Ohio Revised Code, a **FELONY OF THE THIRD DEGREE**, contrary to the form of the statute in such case made and provided and against the peace and dignity of the State of Ohio.

COUNT SEVEN

And the Grand Jurors of the State of Ohio, within and for the body of the County of Summit aforesaid, on their oaths in the name and by the authority of the State of Ohio, DO FURTHER FIND AND PRESENT, that **TERREIONNA SHAVONN PASCHAL** on or about the 19th day of April, 2023, in the County of Summit and State of Ohio aforesaid, did commit the crime of **MISDEMEANOR THEFT** in that she did with purpose to deprive the owner [REDACTED] of property or services, to wit: A Cell Phone, knowingly obtain or exert control over either the property or services without the consent of the owner or person authorized to give consent, in violation of Section 2913.02(A)(1), 2913.02(B)(2) of the Ohio Revised Code, a **MISDEMEANOR OF THE FIRST DEGREE**, contrary to the form of the statute in such case made and provided and against the peace and dignity of the State of Ohio.

COUNT EIGHT

And the Grand Jurors of the State of Ohio, within and for the body of the County of Summit aforesaid, on their oaths in the name and by the authority of the State of Ohio, DO FURTHER FIND AND PRESENT, that **TERREIONNA SHAVONN PASCHAL** on or about the 19th day of April, 2023, in the County of Summit and State of Ohio aforesaid, did commit the crime of **ATTEMPTED THEFT** in that she did with purpose to deprive the owner, [REDACTED] of property or services, to wit: Money, knowingly attempt to obtain or exert control over either the property or services without the consent of the owner or person authorized to give consent, in violation of Section 2923.02 / 2913.02(A)(1), 2913.02(B)(2) of the Ohio Revised Code, a **MISDEMEANOR OF THE FIRST DEGREE**, contrary to the form of the statute in such case made and provided and against the peace and dignity of the State of Ohio.

FURTHERMORE, the property or services stolen is valued at one thousand dollars or more and less than seven thousand five hundred dollars.
