On June 13, 2023, Assistant Prosecuting Attorney Brian Loprinzi on behalf of the State of Ohio and present in the courtroom, and counsels Jeff Laybourne and Noah C. Munyer, appeared before the Court. Counsels and the Defendant, who was in custody, appeared through video.

Defendant was notified of her right to proceed in-person, of her right to waive that right and her right to confer with counsel at any time. Defendant knowingly, voluntarily and intelligently waived her right to an in-person appearance.

ARRAIGNMENT

The Defendant was arraigned upon the Indictment, the reading thereof having been waived, and waiving any defects in time and manner of service, for plea thereto says she is "NOT GUILTY" as she stands charged therein, and puts herself upon the county, and the Assistant Prosecuting Attorney does the same.

BOND

Upon consideration of the factors contained in Crim. R 46, bond is hereby set as: \$2,000,000.00. Said bond may be secured by payment of ten percent (10%) of that said bond amount to the Summit County Clerk of Courts, or by posting that amount in full with the Summit County Clerk of Courts by a commercial surety company.

Additionally, if bond is posted Defendant will be placed on maximum pretrial supervision with restricted GPS monitoring.

Defendant shall have NO CONTACT, either directly or indirectly, or through social media, with the prosecuting witness' family. If Defendant violates any of the terms of this Order, even with a protected person's permission, the Defendant can be arrested and jailed pursuant to R.C. 2951.08(A). Nothing in this Order limits a prosecutor from charging Defendant with new crimes.

All bond documents shall be transferred to the Summit County Clerk of Courts for Common Pleas, and that all previous conditions of remaining on bond from Municipal Court are in full force and effect and are to remain so until terminated by the Court.

If a BCI report is required for use by either the State or Defense, such report shall be ordered forthwith by whichever party anticipates its use.
